#### Q2 Update

Per discussion with the Borrower on the 24<sup>th</sup> April 2019, it was explained that initial progress was 4 - 5 weeks behind schedule as a result of delays in achieving Local Authority ("LA") sign-off of the precommencement planning conditions. Whilst it is commonplace for a development programme to be fluid and therefore these relatively minor initial delays are of limited concern, Proseed has been impressed with the measures taken by the Borrower to recover time following the initial delay. It is also noted that this delay to the programme was outside the Borrower's control and since then they have been proactive with the delivery.

As evidenced in the photos overleaf, the site has since been cleared and laying of foundations is underway. This progress is consistent with the revised schedule presented to Proseed per discussion with the Borrower on the  $24^{th}$  April, where it was explained the ground works team would be onsite for w/c  $3^{rd}$  June.

It was also explained that the transition from groundwork to block laying would be more efficient than initially scheduled. It was explained that a team of block layers working for the Main Contractor on a nearby site would be able to transition onto the Ottershaw site upon immediate completion of the ground works.

The Borrower intends to recover time lost against the overall programme as a result of delays at the LA in this first transition of the build programme and is confident of further time-saving efficiencies throughout the project.

Proseed are pleased with progress following LA sign-off and will continue to monitor the progress with ongoing site visits.
